# Lead beneficiary principle

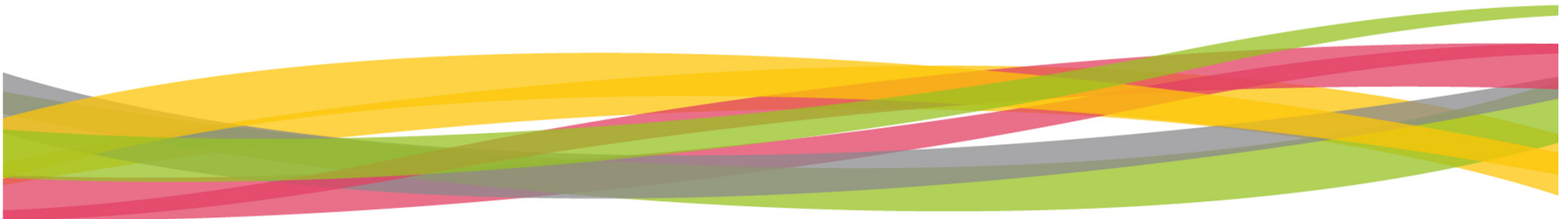
1. Compiled beneficiary activity reports = project level activity report
2. Lead beneficiary decides which tabs need to be filled out by which beneficiary (optional vs. mandatory fields)





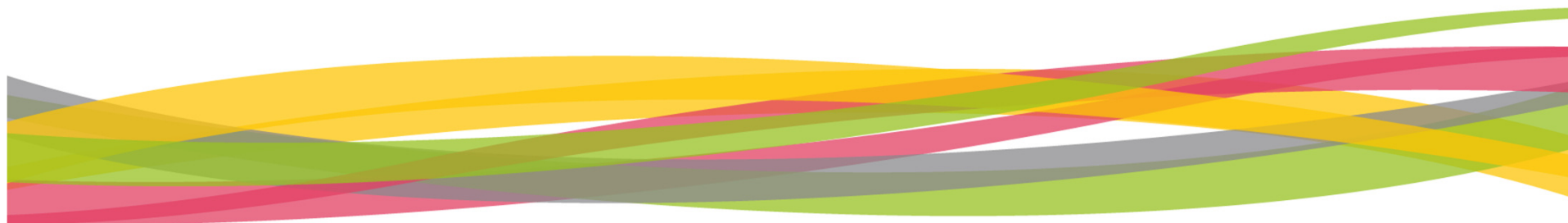

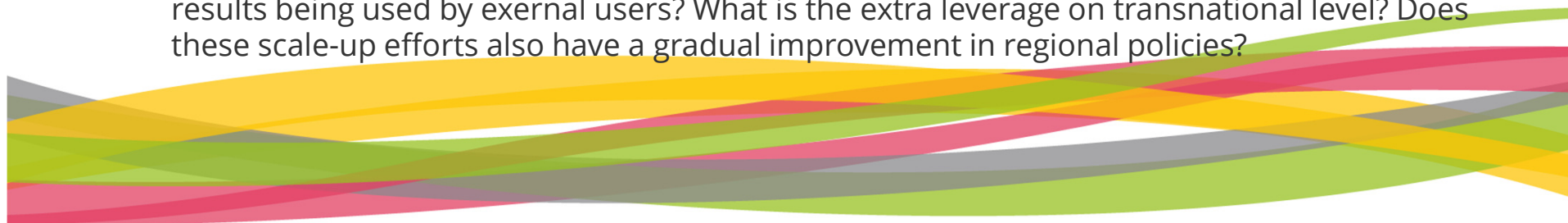
**Knowledge Transfer:** How has the project enhanced / added value to current and former programmes and project(s) it is associated with?

**Activities outside the Programme area :** Were there any activities taking place outside the eligible area during the reporting period?

**Capitalisation:** What's the scale-up of collective actions, outcomes, deliverables and results being used by external users? What is the extra leverage on transnational level? Does these scale-up efforts also have a gradual improvement in regional policies?

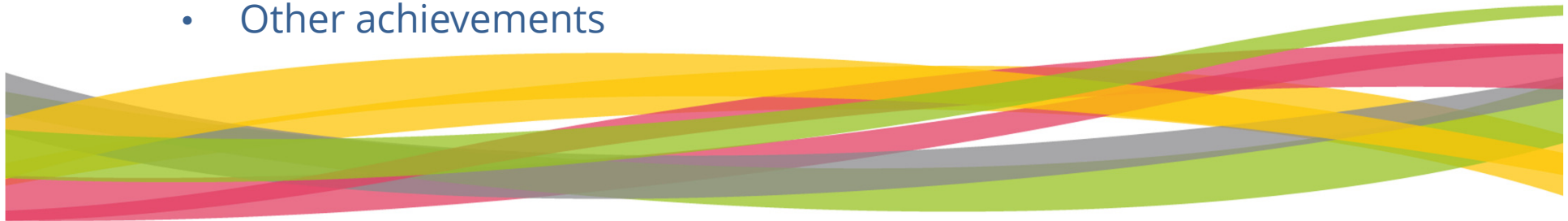

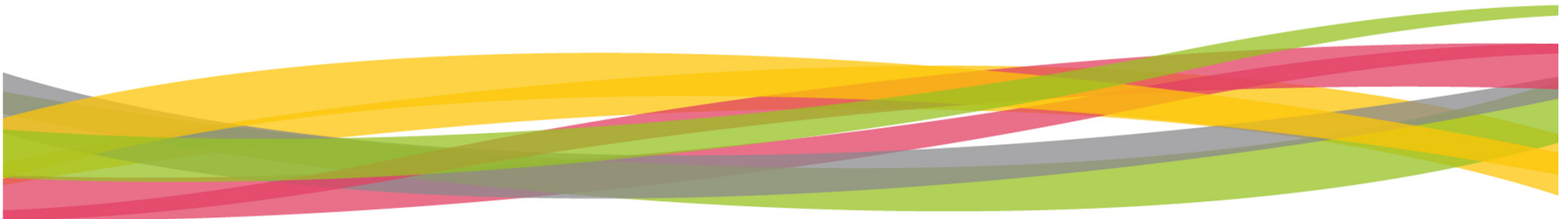

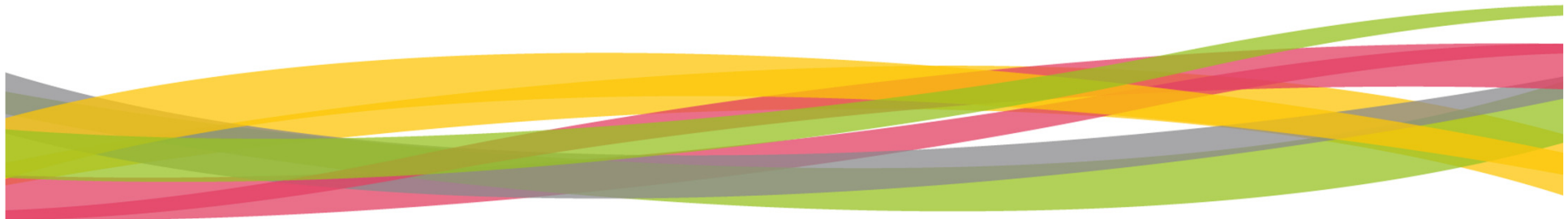
