What is Priority 4 all about?!







Priority 4 – Green transport and mobility

Specific objectives:

- 4.1 Develop demonstrations of innovative and/or improved transport and logistics solutions with potential to move large volumes of freight away from long-distance road transportation
- 4.2 Stimulate the take-up and application of green transport solutions for regional freight and personal transport

Output indicator for both objectives:

Number of new and/or improved green transport solutions adopted









Full Applications approved and applied Call 1

- 4.1 0 projects approved
- 4.2 2 projects approved

European Regional Development Fund (ERDF) amount granted - €3,641,067

Call 2

- 4.1 1 projects applied
- 4.2 3 projects applied

Total ERDF requested - €7,926,753







Expressions of Interest

Call 1

- 4.1 2 Eol approved, not yet applied as FA
- 4.2 0 Eol approved not yet applied as FA ERDF requested €4,900,596

Call 2

- 4.1 0 EOIs applied
- 4.2 7 EOIs applied ERDF requested €9,153,356







Situation after Call 2 - guesstimate

Total ERDF funding allocated to Priority 4: €28,433,175

Funding allocated to approved projects (Call 1)

€3,641,067

Funding for FAs that might be approved in Call 2 $\sim \notin 3,963,377$

EOIs that might be approved as FAs in Call 3 $\sim \in 7,026,976$

Remaining budget for Call 4 Expressions of Interest ~ €13,801,755

All figures are estimates and may change significantly!

The rejected FAs and EOIs


- Unclear, vague, weak results (outputs/deliverables)
- Weak transnational relevance argument
- Lack of focus and specificity
- Weak (or lack of) explanation of how project builds on results of other work, other projects
- Activities do not match objectives
- Weak evidence of 'added value'
- Insufficient justification of investments

- Submit a project idea feedback from the Joint Secretariat is available outside open call periods
- Submit an Expression of Interest development phase in spring of 2017 with events and additional guidance
