#### Short excursions to destinations in the region

- Jühnde the village of renewable biomass
  - Jühnde (Lower Saxony) is Germany's first village to produce heat and electricity by means of renewable biomass (silage and wood chips), thus moving towards CO2 neutrality. Realising the project took 5 years, and delegates will learn about the factors that are essential in keeping a village motivated for such a long time.
- Hann. Münden strong cities and viable villages
  - The southern part of Lower Saxony faces great demographic changes that are mainly due to migration and aging. Also, the distance to large dynamic growth centres is an issue. Visitors will learn how Lower Saxony plans to strengthen the economic structure, preserve viable villages and increase the attractiveness of the region as a place of residence, business location and tourist destination.
- Göttingen a city connected to the North Sea?
  - How is Göttingen connected to the North Sea as a part of the Interreg North Sea Region? Niedersachsen Ports is the largest operator of public seaports in Germany. An ever-increasing exchange of goods and a growing global network put increased demands on seaports and their connection to the hinterland. Can the concept of corridors help to interconnect the North Sea Region better?
