Call 1: 53% | Call 2: 36% | Call 3: 71%





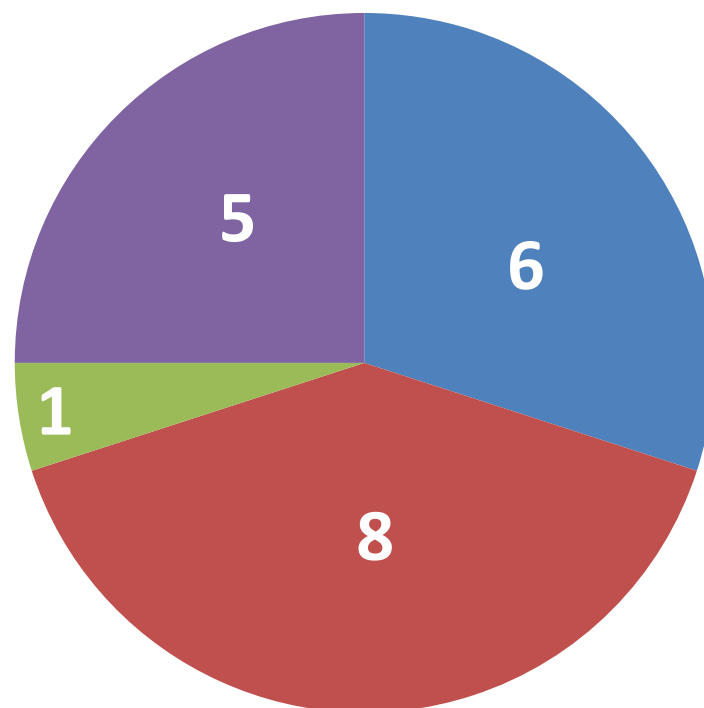

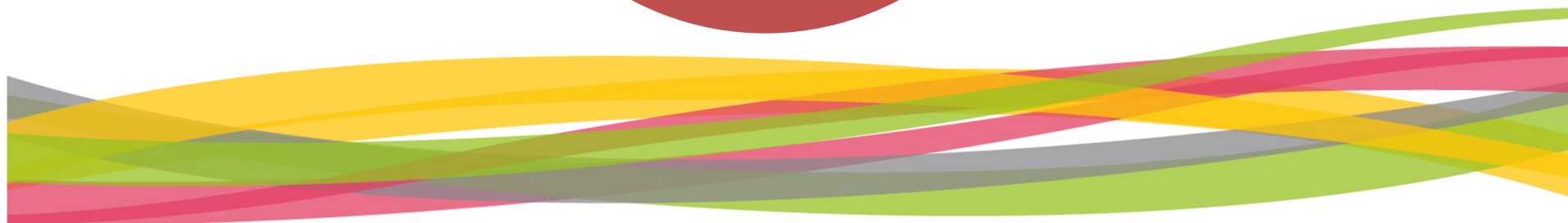




Number of approved EOIs in Call 4 per priority
